HIGHLIGHTS

• South Centre participated in the Latin American Congress titled: "Mother Earth: One Health" held in Rosario, Argentina. The purpose of the meeting was to analyze the multisectoral nature of antimicrobial resistance and environmental health. Ms. Mirza Alas made a presentation on research, development and access to antibiotics and the patent system. The Congress was held on 12-16 June and organized by the Institute of Socio-Environmental Health of the National University of Rosario together with ReAct Latin America and partners. The week long congress gathered people from sixteen countries, social movements, scientific institutions, indigenous communities and others.
