### Biography of Speakers



**Dr. Yilmaz AKYÜZ** is the Chief Economist of the South Centre. He was previously Director of the Division on Globalization and Development Strategies at the United Nations Conference on Trade and Development (UNCTAD) when he retired in August 2003. He was the principal author and head of the team preparing the Trade and Development Report, and UNCTAD coordinator of research support to developing countries (the Group-of-24) in the IMF and the World Bank on International Monetary and Financial Issues. He taught at various universities in Europe before joining UNCTAD in 1984 and after his retirement, and published extensively in macroeconomics, finance, growth and development.



**Dr. Peter DITTUS** is the owner of arCandide consulting and currently working as a consultant to public organisations. Previously he was Secretary General of the Bank for International Settlements from 2005 to 2016. He joined the BIS in 1992 as an economist and since 1995 had assumed increasingly senior responsibilities in the Bank. In 2000, he was appointed Deputy Secretary General and became a member of the Bank's Executive Committee. Before joining the BIS, he worked as an economist at the World Bank and the OECD. Mr Dittus holds a doctorate in economics from Saarbrücken University and diplomas in economics from Saarbrücken University and the University of Michigan. **Mrs. Yuefen LI** is the Special Advisor on Economics and Development Finance of the South Centre. She worked in the United Nations Conference on Trade and Development (UNCTAD) from 1990 to 2014, as Head of the Debt and Development Finance Branch and Manager of UNCTAD projects on Promoting Responsible Sovereign Lending and Borrowing, the Sovereign Debt Workout Mechanism and Globalization. She taught at the University of International Business & Economics in Beijing and subsequently at two other universities as a visiting professor. She has published books, papers and articles in professional journals and newspapers, and contributed extensively to UNCTAD publications and documents.



**Dr. Yaga Venugopal (Y.V.) REDDY** was Governor of the Reserve Bank of India from 2003 to 2008. He was Chairman of the Fourteenth Finance Commission in 2013-14. Previously, he worked in the Government of India as Secretary in the Ministry of Finance, and in the Government of Andhra Pradesh as Principal Secretary. He is also a recipient of the Padma Vibhushan, India's second highest civilian award. Currently, he is Honorary Professor at the Centre for Economic and Social Studies in Hyderabad. He is also a member of the Board of the South Centre.



**Dr. Richard KOZUL-WRIGHT** is the Director of the Globalisation and Development Strategies Division in UNCTAD. From 2011 to 2015 he was Head of the Unit on Economic Cooperation and Integration among Developing Countries also at UNCTAD. In 2007 he was appointed Chief of the Development Strategy and Policy Analysis Unit of the Development Policy and Analysis Division – UN-DESA. Mr. Kozul-Wright joined DESA in 1991 to work on the World Economic and Social Survey and in 1993 moved to UNCTAD where he was a contributor to the World Investment Report, the Trade and Development Report, and the Economic Development in Africa Report. He has published articles and books on a broad range of issues related to economic development and economic history. He holds a Ph.D. in economics from Cambridge University. He is the author, most recently, of *Transforming Economies: Making Industrial Policy Work for Growth, Jobs and Development*.
