#### February 2018

#### HIGHLIGHTS

• South Centre and G77 Briefing on Health-related issues, held on 16 February at the United Nations Headquarters in New York.

The briefing was an exchange among G77 countries with technical support from South Centre staff on key issues in the global health agenda being discussed in New York and in Geneva. These issues include health in the context of the 2030 Sustainable Development Agenda and SDG 3 targets to achieve universal health coverage and access to medicines and vaccines for all, preparations for the UN High Level meetings on Tuberculosis and on Non Communicable Diseases during UNGA 2018, efforts to tackle antimicrobial resistance and the work of the Interagency Coordination Group on AMR (IACG), follow up to the United Nations Secretary-General High-Level Panel on Access to Medicines, and health in the context of frontier issues. With regards to the Geneva based processes, discussion focused on the agenda for the upcoming May 2018 World Health Assembly as well as the ongoing work in the Human Rights Council on the right to health.

The meeting reviewed the substantive work plan in WIPO and WTO for 2018, taking into account intellectual property related developments in other international fora. The aim of the meeting was to collectively identify the priority issues for developing countries and LDCs and develop joint strategies for action.
- 15 February, *Study Visit* from 30 students from the Maastricht Graduate School of Governance (integrated at the United Nations University). Mr. Nirmalya Syam gave a presentation on DIIP work.
