### South Centre Experts Short Biographies

**Dr. Germán VELÁSQUEZ** is the Special Adviser on Policy and Health of the South Centre. He is the former World Health Organization (WHO) Director of the department on Public Health, Innovation and Intellectual Property. He is the President of the University Chair 'Right to health and access to medicines' at the Complutense University of Madrid. He is the author of numerous publications on health economics and intellectual property and access to medicines. Dr. Velásquez has a Master's in Economics and a PhD in Health Economics from the Sorbonne University, Paris, a PhD Honoris Causa on Public Health from the University of Caldas, Colombia and a PhD Honoris Causa from the School of Medicine of the Complutense University of Madrid.

**Ms. Yuefen LI** is the Senior Adviser on South-South Cooperation and Development Finance of the South Centre. She was Head of the Debt and Development Finance Branch of the United Nations Conference on Trade and Development (UNCTAD) where she worked for 24 years. She used to teach in the University of International Business and Economics in China. She has published on various issues including development finance, the Chinese economy, international trade and development strategies. Ms. Li got her Master's degree in the American Graduate School of International Management (Thunderbird) and her Bachelor of Arts degree in Beijing Foreign Studies University in China, and she was also a visiting scholar in the London School of Economics (LSE).

**Dr. Manuel F. MONTES** is the Senior Adviser on Finance and Development and Permanent Observer of the South Centre to the United Nations in New York. He was previously Chief of the Development Strategies and Policy branch at the United Nations Department of Economic and Social Affairs (UN DESA). Before that he was a Program Officer in International Policy for the Ford Foundation. He had been on the economics faculty at the University of the Philippines. His publications have focused on development macroeconomics and finance. Dr. Montes holds a PhD in Economics from Stanford University.

**Dr. Youba SOKONA** is the Senior Adviser on Sustainable Development of the South Centre. He was elected Vice-Chair of the Intergovernmental Panel on Climate Change (IPCC) in October 2015 after previously serving as Co-Chair of the IPCC Working Group III for the Fifth Assessment Report, and Lead Author since 1990. He is affiliated with numerous boards and organizations, including as Honorary Professor at the University College London (UCL), Member of the Science Advisory Committee of the International Institute for Applied Systems Analysis (IIASA), and as a Special Advisor to the African Energy Leaders Group. He has over 35 years of experience addressing energy, environment and sustainable development in Africa. Dr. Sokona has an Engineering PhD in Earth Sciences from the Paris École Nationale Supérieure des Mines and from the Paris Université Pierre et Marie Curie.

**Dr. Humberto CAMPODÓNICO** is Regional Adviser on Economics and Development of the South Centre. He is a Principal Researcher at the Centro de Estudios y Promoción del Desarrollo (DESCO); a Member of the Advisory Board of the Natural Resources Governance Institute (NRGI); a Fellow of the Rights and Resources Initiative (RRI) and economics columnist at the Peruvian national daily La República. He was Regional Adviser at the Economic Commission for Latin America and the Caribbean

(ECLAC); Professor and Dean at the Economics Faculty, Universidad Nacional Mayor de San Marcos; President of PETROPERU; Consultant of the Andean Community of Nations, ECLAC, and UNCTAD. He has published several books about mining, energy (oil, natural gas), and international economics and trade.

**Mr. Vicente Paolo YU** is the Programme Coordinator of the Global Governance for Development Programme (GGDP), and was previously Deputy Executive Director of the South Centre. Prior to joining the South Centre in 2002, he worked for Friends of the Earth International and was the research and policy development director of the Legal Rights and Natural Resources Center in the Philippines. He taught law at the University of the Philippines, and has published articles, papers and other research on, inter alia, energy policy, indigenous peoples rights, multilateral trade policy, climate change policy, South-South cooperation and international environmental policy. He obtained his undergraduate and law degrees from the University of the Philippines, and his master of laws degree (specializing in international trade law and international environmental law) from Georgetown University where he was a Fulbright Scholar.

**Dr. Mariama WILLIAMS** is Senior Programme Officer of the Global Governance for Development Programme (GGDP) of the South Centre. She is also a director of the Institute of Law and Economics (ILE), Jamaica. She was a member of the Expert Advisory Group for the UN Women Global SDG report *Turning promises into action: Gender equality in the 2030 agenda for sustainable development* and also served as an assistant Professor of economics at the Fashion Institute of Technology, the State University of New York. She served on a number of board of directors and trustees and a member of a number of steering committees. She is a feminist economist with over 20 years of experience working and publications on economic development and macroeconomic issues, with a focus on gender equality and women's empowerment and social equity, international trade, external debt and finance and more recently on climate change issues. She obtained her B.A. in Economics and Political Science from New York University and her M.A. and Ph.D. from the New School for Social Research in New York.

**Ms. Monica VICTOR** is Senior Programme Officer of the Global Governance for Development Programme (GGDP) of the South Centre. She has been a Tax Attorney for the Ministry of Finance of Brazil for 25 years. She obtained her LLM in International Law and Economic Integration from the State University of Rio de Janeiro and her LLM in International Organizations with Emphasis in International Economic Organizations from the University of Zurich. She is an SJD Candidate at the Graduate Tax Program, University of Florida. She was elected Vice-Chair of the American Society of International Law (ASIL) Teaching International Law Interest Group, and appointed for the ASIL Investor-State Dispute Settlement Working Group Steering Committee.

**Mr. Adriano José TIMOSSI** is Senior Programme Officer of the Global Governance for Development Programme (GGDP) of the South Centre. Previously, he worked at the Right to Development Section of the United Nations Office of the High Commissioner on Human Rights (OHCHR) and the Unit on Economic Cooperation and Integration among Developing Countries at the Office of the Secretary-General of the United Nations Conference on Trade and Development (UNCTAD). He works on the UN development pillar issues, the Group of 77 and China (G77), the Non-Aligned Movement (NAM), regional integration, South-South Cooperation and provides some support for outreach and partnership activities of the South Centre. He has a Bachelor degree in Agricultural Science in Brazil and a Post-graduate Diploma in European Studies (DAES) at the European College of Parma, Italy.

**Mr. Daniel URIBE** is Programme Officer of the Global Governance for Development Programme (GGDP) of the South Centre.
