Virtual Meeting on the implementation of the UN Declaration on the Rights of the Peasants and other people living in rural areas: what is next?

4th of June 2021, 13h00 – 15h00 CEST

1. Background

The UN General Assembly adopted the UN Declaration on the Rights of the Peasants and other people living in rural areas (UNDROP) in December 2018. Its adoption was not a simple process, as it took many years and resources from Member States, peasant organizations and other entities of people working in rural areas. The UNDROP represented an important step forward to promote the rights of peasants at a global level. It recognizes peasants as a specific group subject to rights, reaffirms existing standards and tailor them to the reality of people living in rural areas, and addresses existing gaps in the protection of peasants' rights including on key subject matters such as the right to land, the right to seeds, the right to means of production and the rights to safe and clean drinking water and sanitation and water-related livelihoods. However, despite its importance, so far, not many countries have implemented the Declaration to date.

Peasants are among the most vulnerable social groups in the world. According to FAO, before the pandemic the number of undernourished people around the world was estimated to have increased to 821 million in 2017 and about more than three quarters of the world's poor population live in rural areas. The COVID-19 pandemic has also hit harder the more vulnerable populations around the world and peasants and rural workers of developing countries are among them.

In this context, despite the difficulties caused by the health crisis, since the last two years some organizations from civil society and peasant organizations, notably La Via Campesina

(LVC), and some countries have started discussions about the status of the implementation of the Declaration and the next steps. In line with these activities, the South Centre is organizing a virtual meeting to analyze the state of play about the implementation of the Declaration and what is next.

2. Objectives of the Virtual meeting

The virtual meeting aims to promote a debate about what kind of actions could be taken to move forward with the implementation of UNDROP. The guiding questions are: where are we now? What other actions are necessary to promote its implementation? What steps could Governments, Civil Society Organizations and the Human Rights Council take towards the implementation of the Declaration? Should it be a priority to take actions internationally or domestically?
