WHO WE ARE

The South Centre is an intergovernmental organization composed of and accountable to developing country Member States.

It was established on July 31, 1995 with headquarters in Geneva, Switzerland. It has 55 member countries.



OUR MISSION

- » The South Centre undertakes policy-oriented research on a set of issues relevant to the achievement of the Sustainable Development Goals.
- » It supports the countries of the South to effectively participate in negotiating processes in order to build up a multilateral system that supports and does not undermine development efforts.
- » To provide policy and technical advice and capacity building in support of countries and institutions of the South.



OUR VISION

- » The empowerment of the Global South to achieve a fairer international trade, tax and investment system, eliminate poverty and inequalities, realize human rights, respond to climate change, fight disease and health emergencies, and harness digital and other technologies for innovation and sustainable development.
- » Expand South-South and Triangular Cooperation as a tool to achieve sustainable development.

1986

Prime Minister Mahathir Mohamad of Malaysia announced that an independent commission, a "South Commission", would be set up to "try and work out solutions to major economic problems faced by the South", from the South's perspective.



1987

The South Commission became operational in August 1987 in Geneva. Composed of twenty-eight distinguished personalities from different walks of life and various parts of the developing world, the Commission examined the problems of developing countries from their perspectives.

1990

The South Centre was established to follow-up the Report of the South Commission, entitled "The Challenge to the South", which provided recommendations on what the South could do to address continuing development challenges. It called for the South to work together collectively and to create a South Secretariat.

1995

The South Centre became an intergovernmental organization through the 1994 Agreement to Establish the South Centre, with its headquarters in Geneva. The Agreement is deposited with the United Nations.

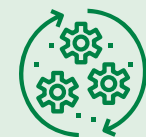

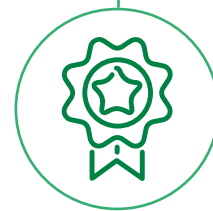
