The South Centre is key in many aspects for developing countries, but one deserves to be highlighted: it broadens the spectrum of possible discourses. Indeed, discussion topics and alternatives for solutions in international organizations are often constrained by narrow thinking, by good manners, and by path-dependency. Debates tend to remain excessively targeted and often repetitive. The South Centre is an antidote to this. The South Centre provides developing Members with broad, contextual thinking; with original ideas; and with political space that allows movements of national positions and policy choices. Whenever the South Centre introduces a new issue or proposes an alternative — always with a high level of technical expertise — it offers Members a window of opportunity to expand their thinking, enrich their speeches, and adjust their stances, both at the international and the national levels. It is truly a great helping hand to have.

Moreover, achieving poverty eradication, sustainable development, a fair green transition and sustainable technological upgrades, requires national policies and an international regime that support, rather than undermine, such efforts. In this regard, the South Centre's role is critical. As an intergovernmental policy research think-tank composed of -and accountable to-developing country Member States, the Centre conducts policy-oriented research on key development issues and supports developing countries to effectively participate in international negotiations relevant to the achievement of the SDGs. It promotes unity among the countries of the South, while fully recognizing the diversity of their national interests and priorities. Through its work, the South Centre empowers developing countries to break through the constraints of conventional discourse and advance more equitable, creative, and development-centered solutions. It is, indeed, an invaluable ally.

I begin with a heartfelt apology. We have been unable to summarise in one or two few paragraphs, as requested, Cuba's message on the occasion of the South Centre's 30th anniversary, whose history is inexorably linked to the struggle of the countries of the South for their legitimate rights.

The purposes behind the founding of this institution hold greater significance today than ever, as we face an increasingly complex and challenging world.

In the midst of the 21st century, it is unacceptable that a profoundly unjust, undemocratic, and exclusionary international order continues to be imposed on most nations on the planet. Such a system is only effective in perpetuating imbalance and multiplying inequalities, poverty, hunger and exclusion. A very small minority enjoys exponential increases in wealth, while the vast majorities struggle for survival.

Our peoples cannot and must not remain testing grounds for colonial prescriptions and renewed forms of domination that perpetuate underdevelopment while filling the coffers of a select few at the expense of the South.

The alternative to the prevailing imbalances cannot stem from outdated prescriptions and governance models. Either just ideas will prevail, or disaster will strike.

Day after day, the Centre proves through its studies, analyses, and proposals that an alternative form of globalisation-a fairer and more sustainable one- is indeed possible. Its prompt, timely, and consistently well- substantiated recommendations on issues of the utmost importance to developing countries have become a hallmark of this institution.

Over the past 30 years, the South Centre has been far more than a space for research, analysis, and advisory services. It has served as a forum for reflection and debate, an untiring creator of collective awareness, and an indispensable architect of alternative synergies and narratives.

We need the Centre to continue supporting those of us who raise our voices against domination and hegemony, unilateral coercive measures, genocidal blockades such as the one imposed on the Cuban people, and the attempts to impose a single culture and model upon the world.

The Centre must remain a catalytic force in the efforts of developing countries to speak with a unified voice and close ranks against those who seek to divide us, render our realities invisible, and curtail our rights. Only through cohesion can developing countries become a key player in defending the interests of our peoples.

Cuba, as one of the founding nations of the Centre, has borne witness to its unwavering commitment to promoting the unity of the South in its diversity and advancing the progress of the South through cooperation.

Ever since the South Centre was founded, it has been an ally, consistently alerting us to emerging challenges that compound the traditional ones, while persistently urging us not to underestimate the pressing issues at hand. It has become an authentic and reliable voice, earning well-deserved prestige through its work.

The South Centre's 30th Anniversary reaches us in a time where unilateralism is being praised and the long US based international rules are being destroyed by the US itself. Those US based multilateral rules which the South Centre for 30 years has intensively worked to amend and make more favourable, just, equitable and workable in favour of the growth and development of developing and least developed countries, are now facing dissolution and replacement by a system based on individual power, arbitrariness, unilateral sanctions, the law of the strongest and the interests of the most developed world economies.

Under these conditions, the role of the South Centre needs to be revisited under two sets of agreements. Those that protect and defend their members from pervasive unilateral action of the strongest economies and attempts to force them to align with one or the other major powers. And those based on the rules the South Centre have been proposing for 30 years to amend the international multilateral system in favour of convergence and sustainable development. Special efforts must be made to rethink the intellectual property rights system to make it more compatible with competition, innovation, conservation and sustainability.

Past President of the competition and intellectual property authority in Perú (INDECOPI) Professor of Economics, CENTRUM Graduate Business School, Pontificia Universidad Católica del Perú The South Centre has much to celebrate as it commemorates its 30th anniversary. A quarter century ago, as a young Rockefeller Foundation program officer, I had recognized then, and it remains true today, that without equity and fairness in access to knowledge, the divide between have's and have not's in this world would never be bridged. Lifting up the voices from the Global South would be critical to leveling the playing field in shaping the global debates over intellectual property rights. So the Foundation invested in the voice of an emerging legal scholar working with the South Centre, later joined to a process with the World Health Organization, on intellectual property rights and access to medicines. That voice, Carlos Correa, would later become the Executive Director of the South Centre.

Leaving the Foundation, I turned my attention to the challenge of tackling antimicrobial resistance. Drug-resistant pathogens crossed borders readily, making this a global health issue, where the biology of drug resistance and the economics of bringing antibiotics to market were at odds. The South Centre recognized the catalytic importance of ensuring this cornerstone to modern-day medicine that defied traditional business models would require a coordinated global response to address both the scientific and economic challenges. It coorganized and hosted our founding of the Antibiotic Resistance Coalition in 2014 as the first intersectoral coalition of civil society groups and the South Centre. Our Innovation+Design Enabling Access (IDEA) Initiative at the Johns Hopkins Bloomberg School of Public Health continues to partner with the South Centre. Working with the next generation of South Centre leaders, Viviana Muñoz Tellez, we laid out a vision for the next steps for global governance and policy action to address antimicrobial resistance, in the lead up to the UN General Assembly's High-Level Meeting this past September. It has been a remarkable journey, and no doubt, the South Centre will continue to play a vital role in shaping global health policy and access to knowledge for decades to come.

We believe that the point of scholarship is to change the system. Academic journals are not sufficient to impact policymaking in *realtime*. We are grateful to The South Centre for expediting publications. Through The South Centre Research Papers, we have levered and expanded our arguments previously published in the peer-reviewed literature.

A Google Search of the "Global Multilateral Benefit-sharing Mechanism" (Article 10 of the Nagoya Protocol to the UNCBD) continues to rank our Research Paper No. 160 as a top hit-some three years after its publication. Even more heartening, a Google Search of the landmark "Decision 15/9" ranked Research Paper No. 210 as *the* top hit during COP16 in October 2024. The South Centre instills hope that the system will change.

Joseph Henry Vogel, Professor of Economics, University of Puerto Rico-Río Piedras Manuel Ruiz Muller, International Legal Consultant

I got to know of the South Centre in 2012 when I started working for SEATINI-Uganda. At that time, the Economic Partnership Agreement (EPA) Negotiations between the European Union (EU) and African Regional Economic Communities (RECs) were at their height. While with onerous provisions which could negatively impact regional integration, revenue and industrialisation in Africa, the EU mounting pressure on African RECs and individual countries therein (especially the non-LDCs) to finalise the negotiations and eventually ratify the EPA. Through policy papers, memos on counter proposals, briefing notes and discussion papers, the South Centre stepped in to convince African countries like Tanzania, Uganda and Nigeria to rethink the rushed conclusion of the EPAs. To date, thanks to efforts by the South Centre which even supported African CSOs in the same way, the EPAs remain largely unratified by RECs like the East African Community (EAC) and Economic Community of West African States (ECOWAS).

Finally, the South Centre has been critical in supporting research and publication by scholars from the Global South, giving them a voice to speak to development policy. I have been one of the privileged to have my Paper on the African Continental Free Trade Area (AfCFTA) published when key journals rejected it on grounds of it being too critical of the AfCFTA. But by being objective and yet impartial, the South Centre published this paper, giving it a bigger and international platform to speak to policy makers and development commentators on regional integration in Africa. I therefore commend the South Centre for its 30 years Anniversary and thank it for remaining steadfast in its goal of being the voice for the global south in development policy.

## Other Reflections

There are many things that the developing world remembers Julius Nyerere for, and one of these is the founding of the South Centre as a global South think tank on world issues. Given its limited resources, the contribution the South Centre has made in articulating the developing world perspective on global issues is remarkable. While the West has umpteen institutions tirelessly producing policy analysis outputs to be subsequently adopted as global, even as they are grossly unfair on the North-South divide, in the South we have barely a few such independent institutions, even the rare ones we have often depend on western funding for their existence, with predictable impact on their outputs. South Centre's significance therefore is critical.

My relation with the Centre dates back to its early years. I am happy that some of my contributions to the South Bulletin and SouthViews have created impact even beyond my expectations. My article on the failure of the Convention on Biological Diversity in implementing the pro-South provisions of the treaty- in the making of which I had been a negotiator- as well as the one explaining why the national sovereignty provision of CBD is not negotiable have been widely used by CBD negotiators. The SouthViews I wrote on the further silencing of the South-friendly provisions, following the adoption of the Global Biodiversity Framework, ended up with me corresponding with a lot of negotiators from the global South. I am particularly happy that the SouthViews essay I wrote on the need for criminalizing ecocide had many takers of the concept and a few countries have even introduced such legislation. That is the influence of SouthViews, not mine.

I would very much like the South Centre to expand adequately to be able to cater to the massive demand for policy analysis related to multilateral negotiations, even by having a subcentre in one of the developing countries. As the rule based multilateralism is falling apart in recent years, it is important that the South Centre advance its capacities to produce robust studies and negotiation briefs to help strengthen democratic multilateralism. I send all the best wishes to the Centre in these efforts.
